Remark 3: Students are required to take service learning before graduation and obtain the graduation qualification. Please refer to the requirement of the university.

備註3: 校外實習每1學分應達之時數依本校校外實習相關規定辦理。校外實習學分之認列【暑假+上學期合計上限為4學分】; 【下學期學分上限為8學分】。

Remark 3: The internship duration follows the requirement of the university. Maximum of 4 credits of the fall semesters and 8 credits of the spring semesters could be counted toward total credits required for graduation.

Remark 4: Students are required to pass the professional ability thresholds of the department for graduation. Students who do not meet the requirements must take and pass credits of "Certificate of Finance". Please refer to the requirement of the department.

Remark 5: Maximum of half credits of the electives each semester could be counted from other programs and departments and toward total credits required for graduation.
